## INTRODUCTION

Moreco Group Limited, trading as Milk & More, is committed to improving our practices to ensure there is no modern slavery or human trafficking in our business or supply chains. This is our modern slavery statement, made pursuant to section 54(6) of the UK Modern Slavery Act 2022, setting out the steps taken by Milk & More during the financial year ended 31 December 2025 and was approved by the board of Milk & More.

Milk & More was previously part of Muller UK and became part of the Freshways group (the UK's largest private dairy processor) in January 2024. It has its head office in Camberley and has a further 31 sites in the UK, employing around 1100 people.

## OUR BUSINESS

Milk & More delivers daily essentials, such as milk, eggs and bread, through the night in time for breakfast, making nearly 1 million deliveries each week. This is achieved through our network of local fulfilment centers and a team of traditional milkmen and women.

## OUR SUPPLY CHAINS

We source our direct goods from a wide variety of suppliers, from large major UK suppliers, through to smaller regional and artisan suppliers. All our milk is UK sourced and bottled by a small number of local dairies and also by Freshways.

All other products we sold are procured by Freshways using its own policies and procedures. Other indirect goods and services that we procure are supplied by suppliers that are screened and chosen in accordance with our internal policies and procedures.

## MODERN SLAVERY AND HUMAN TRAFFICKING POLICIES

As part of our commitment to ensure there is no modern slavery or human trafficking in our supply chains, we have a number of policies in place, and these are regularly reviewed and updated.

Our Anti-Slavery and Human Trafficking policy reflects our commitment to acting ethically and with integrity throughout the business, including in our supply chains, and sets out an expectation of the same high standards from all contractors, suppliers and other business partners.

Our Whistleblowing policy applies to all employees, suppliers, agents and any other

person associated with Milk & More, providing a process for anyone to raise concerns safely and confidentially.

Our standard terms and conditions for the purchase of goods and/or services require suppliers to comply with all applicable laws and regulations including, without limitation, those relating to anti- slavery and human trafficking, including the Modern Slavery Act 2015, and those relating to anti- bribery, including the Bribery Act 2010.

Responsible recruitment is overseen by our HR department in accordance with our HR policies and selection processes. These ensure that recruitment is carried out fairly and that valid right to work documentation is checked.

Where recruitment agencies are used to supply temporary workers, we operate a preferred supplier list of agencies who are expected to undertake the appropriate background checks on prospective employees.

## **DUE DILLIGENCE PROCESSES FOR MODERN SLAVERY AND HUMAN TRAFFICKING**

As part of our processes to identify and mitigate risks as a business, a contract management process operates across the business to capture all suppliers and contracts and ensure they are centrally managed across the business. Procedures for good contract governance have been put in place to help identify any supplier issues, together with standardised supplier onboarding processes that require suppliers to provide certain information prior to award of contract.

We validate the identity of all permanent employees and ensure that they have the legal right to work in the UK.

Our Anti-Slavery and Human Trafficking policy, as well as our Whistleblowing policy, is communicated to all employees across the business and is accessible via the Milk & More intranet, enabling employees to understand how to identify and report any potential issues across our supply chains.

## **EFFECTIVENESS IN MEASURING AND MANAGING RISK**

We take a risk-based approach to assess, track and monitor adherence to regulatory requirements and ethical practices and carry out routine risk assessments of our supply chain.

Much of the milk and the majority of the products sold by us are procured through Freshways, and risks in this supply chain are considered to be low risk. The majority of indirect products and services are purchased from large, sophisticated organisations which also have robust processes to guard against instances of modern slavery occurring in their own supply chain.

We can be confident that the steps we are taking to ensure slavery and/ or human trafficking is not taking place within our business are sufficient because policies and requirements having been set and communicated, there is an absence of reports or

findings from employees or suppliers, or public or law enforcement agencies, to indicate modern slavery practices have been identified.

## **TRAINING AND AWARENESS**

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and business, we provide induction and training to all employees, permanent and temporary. This includes all management employees.

## **CONTINUOUS IMPROVEMENT MEASURES**

During the next financial year, Milk & More will:

- Continue to build upon and maintain our due diligence processes to identify, prioritise and act upon modern slavery and human trafficking risks within our business and supply chain.
- Continue to the roll out of its Supplier Code of Conduct (launched in 2024) to remaining suppliers and work more closely in the co-ordination of purchasing and supply chain issues.
- Continue to educate leadership and employees across Milk & More on commitments to eradicating modern slavery and human trafficking in supply chains by providing ongoing support and training.

I am pleased to approve this statement on behalf of Moreco Group Limited and together with the executive leadership, will ensure that it is reviewed annually.
